Advocacy

When children have access to quality early child care and education, we all benefit. It's an investment, not a "cost." At the Council, we believe that the brain growth and opportunities afforded by these early experiences should be available to every child, rather than just a privileged few. This requires public investment. We're urging the Westchester County Executive and legislators to increase subsidy reimbursement rates in the 2019 budget, so that child care providers and programs can retain caring, well-trained staff who are paid enough to support their own families.





Access

Our **Key to the Future Fund** provides child care scholarships to hardworking families who need a little bit of help to afford Westchester's high-priced quality early care and education. Each time a scholarship is awarded, another child passes through a door that would otherwise have remain locked. On the other side, she has a lifetime to explore possibilities and meet her potential... thanks to you.

So far this season, through the live "fund a need" at our 50th anniversary celebration and #GivingTuesday, you have donated over \$55,000 for children in need. Our goal is \$75,000 by year's end. 


Resources
